## SCHEDULE OF GRAIN INSPECTION FEES

**EFFECTIVE DATE:** February 1, 2001 Federal Grain Inspection Service (FGIS) must approve all fees for official services and official agencies will assess only those fees appearing on their current approved fee schedules.

**NORMAL WORK HOURS:** Monday through Friday 8:00 a.m. to 4:00 p.m.

<u>HOURLY RATES:</u>	<u>Samplers</u>	<u>Inspectors</u>
Regular hourly rates:	\$ 9.00	\$13.75
Overtime: (other than normal work hours)	\$13.50	\$20.63
Sunday and Holiday:	\$18.00	\$27.50


All hourly rates will be assessed in quarter hour increments.

**HOLIDAYS:** New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Day, and any other day observed by the Grain Industry.

**MILEAGE and TRAVEL CHARGES:** \$.275 per mile traveled. Travel time will be charged at the applicable hourly rate. Mileage and travel time will not be charged for barge loading or when 25 or more carriers are loaded at one location.

Sampling only, per land carrier, plus hourly sampling rate .....	4.00
Sampling only, all other, per 1,000 bu., plus hourly sampling rate .....	1.50

- StarLink testing with grade when applicant provides test kit \$4.00 per test strip.
- StarLink testing with grade when applicant does not provide test kit \$10.00 per test strip.
- StarLink testing without grade when applicant provides test kit \$5.00 per test strip.
- StarLink testing without grade when applicant does not provide test kit \$11.00 per test strip.

Preparing and forwarding samples will be charged at the rate of \$2.50 per sample plus actual costs incurred for packaging materials and delivery.

Miscellaneous requests not covered by this fee schedule will be charged at the applicable hourly rate.

Standby time will be charged at the applicable hourly rate for all applicant caused delays.  
15% discount will be given for 75 or more barges loaded at one location within one calendar month.
