**GRAIN INSPECTION FEES AND CHARGES**

EFFECTIVE DATE: April 1, 2003. Federal Grain Inspection Service (FGIS) must approve all fees for official services and official agencies will assess only those fees appearing on their current approved fee schedule. FGIS user fees included.

REGULAR HOURS: 7:30 a.m. to 4:30 p.m. Monday thru Friday except holidays. All other weekly hours, Saturday, Sunday, and Holidays will be considered overtime. Holidays include New Years Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, and Christmas Day.

HOURLY RATES: \$12.00 per hour per individual during regularly scheduled hours and \$18.00 per hour per individual during overtime hours, assessed in quarter-hour increments. Overtime will be assessed in addition to unit fees with a four-hour minimum for service performed on Saturday, Sunday, or Holidays. Travel time will be assessed at the applicable hourly rate for service with a one-hour minimum charge.

MILEAGE: \$0.345 per mile for actual miles traveled. Mileage prorated where appropriate i.e., more than one location serviced in one trip.

TIMELY PAYMENT AND ASSESSMENT OF FINANCE CHARGES: Invoices will be issued monthly. Payment is due upon receipt of the invoice. If payment is not received within 60 days after the invoice date, additional finance charges will be applied as allowed by the State of Arizona. In addition, service may be withheld until the delinquent account is paid and/or a cash deposit is made guaranteeing payment for future services. **See additional information listed under other services not covered under the United States Grain Standards Act (USGSA)**


**APPLICANT SELECTED SAMPLE DELIVERY** (method cost, i.e., sampler travel time and mileage, actual cost of postage, freight, bus charges, express service etc)

For onsite labs, contracts may be arranged on a case by case basis.

Contracts: General – A contract may be negotiated with any applicant to provide more cost-effective service. Specific concessions may apply on a per contract basis.

Official Commercial Inspection Service is available and will be provided on a case by case basis.

Services not covered by the above fees will be assessed the appropriate hourly rate.


