FEES and CHARGES

#### DEFINITIONS

1. "Regular hours" means 7:00 a.m. to 4:30 p.m., Monday through Friday. Regular hours for samplers may be adjusted to the elevator's hours of operation, but will not exceed eight hours per day.
2. "Overtime" means work performed during any hour other than the regular hours or holiday hours as defined.
3. "Travel time" means time spend in round trip travel from portal to portal. If an employee performs inspections at several locations on one trip, travel time may be prorated.
4. "Holidays" means:

New Years Day	Memorial Day	Fourth of July
Labor Day	Thanksgiving Day	Christmas Day
5. "Call in" and 'call back" means any work performed when the employee is call back to work after a regular work schedule.

Official inspection includes grading and sampling, except where indicated in the schedule.

Official commercial inspection service is provided upon agreement between Kansas Grain Inspection Service, Inc and the applicant. Fees charged are dependent upon modification to the service. Mileage: The IRS standard mileage rate will be assessed for all services performed outside the service point city's limit. Any charge to the mileage rate is effective when the IRS changes their standard mileage rate.

Note: If inspections are performed at several points on a trip, the mileage expenses may be prorated.

When no fee for service has been established, the hourly rate will apply.

For on-site inspections where 5 or more carlots per hour are loaded, the hourly rate will not apply.

For on-site inspection, two employees will be provided at the unit fee charge. Additional employees will be charged at the appropriate hourly rate.

For those inspections for which fees are based on an hourly rate, neither the overtime hourly rate nor the holiday hourly rate will be applied in addition to the regular hourly rate.

If an employee is called in or back, a minimum of two hours at the overtime hourly rate shall be charged.

Interest will be assessed on unpaid accounts which are in excess of 60 days. The rate of interest charged will be set by the KGIS trustees and will not exceed 18% A.P.R.
