

Thank you for your inquiry regarding the proposed San Luis Valley-Calumet-Comanche Transmission Project. FEMA's major concern is that the land is not located in an A Zone. We recommend that you contact the local Floodplain Managers, Ken Vanwarden in Alamosa County at 719-589-3812 or Steven Channel in Huerfano County at 719-738-1220, to receive further guidelines regarding the impact that the purchase might have to the regulations and policies of the National Flood Insurance Program. Considering that floods are the most devastating of all natural disasters in this country, any efforts to reduce the impacts of that hazard is a worthwhile undertaking especially with what Colorado has experienced in the past.
