**FAO Call for data and information, stakeholder consultation and experts on Antimicrobials**: The FAO Committee on Agriculture Sub-Committee on Livestock has requested FAO to collect scientific evidence on alternative feeding practices to replace the use of medically important antimicrobial growth promoters (AGPs), their effectiveness and safety, and to conduct an inventory of these alternative feeding practices. In addition, the Sub-Committee has requested FAO to share successful experiences and good practices, including traditional knowledge (e.g. the use of traditional remedies such as plant-based growth promoters), to support its Members to reduce the need for antimicrobials, and to collect data on the impact of measures to phase out or ban the use of medically important AGPs on livestock production, health and welfare. FAO will organize an Expert Meeting at FAO Headquarters in Rome, Italy, in July 2023, to take into consideration the data and information provided as a response to an open call and the inputs provided by a stakeholder consultation. **FAO/IOC/IAEA:** The Joint FAO/Intergovernmental Oceanographic Commission (IOC)/International Atomic Energy Agency (IAEA) technical guidance for the implementation of early warning systems for harmful algal blooms (HABs) was recently published. The document will guide competent authorities and relevant institutions involved in consumer protection or environmental monitoring to implement early warning systems for HABs present in their areas (marine and brackish waters), specifically those affecting food safety or food security (benthic HABs, fish-killing HABs, pelagic toxic HABs, and cyanobacteria HABs).
