**FAO/IOC/IAEA**: The Joint FAO/Intergovernmental Oceanographic Commission (IOC)/International Atomic Energy Agency (IAEA) technical guidance for the implementation of early warning systems for harmful algal blooms (HABs) was recently published. The document will guide competent authorities and relevant institutions involved in consumer protection or environmental monitoring to implement early warning systems for HABs present in their areas (marine and brackish waters), specifically those affecting food safety or food security (benthic HABs, fish-killing HABs, pelagic toxic HABs, and cyanobacteria HABs).
