Codex Committee on Fish and Fishery Products (CCFFP)

The CCFFP was re-activated at the 43rd Session of the Codex Alimentarius Commission (November 2020) and will conduct its 35th session by correspondence, from September 20–October 25, 2021. The 35th Session of CCFFP will evaluate if the *Standard for Canned Sardines and Sardine-Type Products* (CXS 94-1981) could be amended to include the fish species S. lemuru (Bali Sardinella) in the list of Sardinella species under section 2.1. This is in accordance with the *Procedure for the Inclusion of Additional Species in Codex Standards for Fish and Fishery Products*. JEMRA Report: The Joint FAO/WHO Expert Meetings on Microbiological Risk Assessment (JEMRA) report - Microbiological Risk Assessment Guidance for Food has been published. The report provides guidance on undertaking risk assessment of all microbial hazards which may adversely affect human health in foods along the food supply chain. This report is also intended to provide practical guidance on a structured framework for carrying out risk assessment of microbiological hazards in foods, focusing on the four components including hazard identification, hazard characterization, exposure assessment and risk characterization.
