1890's USDA Initiatives: Supports initiatives on Historically Black Colleges and Universities and the USDA 1890 institutions (Land Grant colleges and universities). USDA maintains an agricultural liaison office at each of the 17 1890 campuses, including Tuskegee University. The 1890s USDA Initiatives will be combined into the Agency Partnership Outreach program.

<u>Advisory Committee Liaison Services</u>: The Office of the Secretary provides guidance and direction to USDA agencies on Advisory Committees and Boards. Costs to support this function and screening/selection of members are reimbursed from agencies to the Office of the Secretary.

<u>Classified National Security Information</u>: Ensures USDA employees are properly cleared and appropriately trained to handle classified information. Provides sound technical policy and guidance on classified information management and security services. Continues modernization efforts consistent with the classification management policy from the Information Security Oversight Office for the control, protection, and over classification goals outlined in EO13526. The development and management of the Security Information Management System. Classified National Security Information will be combined into the Personnel and Document Security program.

<u>Continuity of Operations Planning (COOP):</u> Provides for USDA COOP activities including awareness training, exercises and COOP plan reviews. Continuity of Operations Planning will be combined into the Security Operations program.

<u>Emergency Operations Center:</u> Operates a secure emergency operations center on a 24/7 basis. The center provides critical communications and coordination systems. Emergency Operations Center will be combined into the Security Operations program.

<u>Facility and Infrastructure Review and Assessment</u>: Provides risk-based security assessments with countermeasure recommendations for all critical infrastructures within USDA agencies. Facility and Infrastructure Review and Assessment will be combined into the Security Operations program.

<u>Faith-Based Initiatives and Neighborhood Partnerships:</u> Provides for Department level oversight of the USDA implementation efforts in the faith-based and neighborhood outreach areas and support of the White House Office of Faith-Based and Community Initiatives regional outreach conferences. This office was established at the U.S. Department of Agriculture by executive order on December 12, 2002. Faith-Based Initiatives and Neighborhood Partnerships will be combined into the Agency Partnership Outreach program.

<u>Hispanic-Serving Institutions National Program:</u> Fosters educational excellence in the Hispanic community and promotes Hispanic participation in fulfilling the USDA mission. The Hispanic Serving Institutions National Program will be combined into the Agency Partnership Outreach program.

<u>Honor Awards:</u> Designed to recognize significant accomplishments of USDA employees through the Department's highest honor awards program.

<u>Human Resources Self-Service Dashboard (formerly Retirement Processor/Web Application):</u> Serves as an e-authenticated single sign-on portal for several USDA human resources systems and contains a historical database that together with the Retirement Processor Web application enables employees to run various retirement calculation scenarios.

<u>Human Resources Transformation Programs:</u> Establishes policy, coordinates, and evaluates the USDA agencies' efforts to carry out strategic hiring and support a variety of coordinated employee work life programs. Supports the implementation of Annual Hiring Plans by working with agencies and offices to conduct strategic recruiting. Tracks progress of USDA agencies' towards hiring goals. Provides leadership for work life programs that help ensure employee retention. Beginning in FY 2019, Human Resources Transformation Programs will no longer receive Departmental Shared Cost Program funding.

<u>Identity and Access Management (formerly HSPD-12):</u> Supports the implementation of the Homeland Security Presidential Directive 12 (the Common Identification Standard for Federal Employees and Contractors). Identity and Access Management will be combined into the Security Operations program.

Intertribal Technical Assistance Network: Program addresses the unique challenges faced by American Indian and Alaskan Native tribal governments, communities and individuals in effectively utilizing USDA programs and services. These challenges require intensive technical assistance and program access improvement through an intertribal coordinated network and coordination with the Department of the Interior/Bureau of Indian Affairs, which also has jurisdiction and authority over Indian lands. Information on all USDA programs will be covered by the technical assistance efforts of staff within the Network. Program efforts will also focus on promoting the Department's Strategic Goals within Indian Country, including Tribal consultation responsibilities, in accordance with government-to-government and trust responsibilities of USDA.

<u>Medical Services:</u> Provides preventative health measures such as flu shots, health screening, nutritional principles and fitness awareness that lead to a higher quality workforce environment for employees, and contractors in the National Capital Region (includes the Headquarters complex, the George Washington Carver Center and the Patriot Plaza offices).

<u>People's Garden:</u> Addresses community-based agriculture in rural, urban and suburban communities. It was created in 2010 in order to promote and demonstrate the Department's key messages on health and nutrition, childhood obesity, hunger, sustainable agriculture, and community development.

<u>Personnel Security (formerly Personnel and Document Security):</u> Responsible for ensuring the proper protection of classified national security information through the adjudicative process of personnel clearances. Personnel Security will be combined into the Personnel and Document Security program.

Security Detail (formerly Preauthorized Funding): Provides funding for the Secretary's security detail.

<u>TARGET Center:</u> Supports the Department's workforce diversity and Federal Workforce 2001 policies and provides information on technologies to ensure equal access to electronic technologies and automated systems essential to today's jobs for people with visual, hearing, speech, mobility, or dexterity impairments. The program now includes the general administration of sign language interpreter services.

<u>USDA 1994 Programs:</u> Promotes, fosters, and encourages implementing programs for improving post-secondary and higher education opportunities for American Indians, and establishing information centers for post-secondary and higher education institutions. USDA 1994 Programs will be combined into the Agency Partnership Outreach program.

<u>Virtual University</u>: The Virtual University program will provide Department employees with a central educational facility. The facility will focus on providing employees with training for today's workplace responsibilities and developmental programs to ensure a cadre of highly skilled future leaders. Beginning in FY 2019, Virtual University will no longer receive Departmental Shared Cost Program funding.
