)	CONSENT DECISION AND ORDER AS

This proceeding was instituted under the Horse Protection Act, as amended (15 U.S.C. § 1821 et seq.)(HPA or Act), by a complaint filed by the Administrator of the Animal and Plant Health Inspection Service, United States Department of Agriculture (APHIS), on January 10. 2017, alleging that the respondents violated the Act.

Respondent Brad Beard admits the jurisdictional allegations as to him in the second amended complaint, specifically admits that the Secretary has jurisdiction in this matter, denies the remaining allegations, and waives oral hearing and further procedure. The parties consent and agree to the entry of this decision for the purpose of settling this proceeding as to respondent Brad Beard, and resolving any and all other alleged or potential violations of the Act by him occurring up to and including September 2, 2018. This decision is entered pursuant to the consent decision provisions of the Rules of Practice applicable to this proceeding (7 C.F.R. § 1.138).

Findings of Fact

- 1. Respondent Brad Beard, also known as William Bradley Beard, is an individual residing in (b) (6) and at all times mentioned herein was a "person" and an "exhibitor," as those terms are defined in the regulations promulgated under the Act (9 C.F.R. Parts 11 and 12).
- 2. On or about August 26, 2016, respondent Brad Bead entered a horse (Spooky Jazz) for showing in class 53 in a horse show in Shelbyville, Tennessee.

- 3. On or about August 26, 2016, respondent Brad Bead entered a horse (Ritzie General) for showing in class 55 in a horse show in Shelbyville, Tennessee.
- 4. On August 28, 2016, respondent Brad Beard entered a horse (The Dixie Label) for showing in class 94B in a horse show in Shelbyville, Tennessee.
- 5. On or about August 31, 2016, respondent Brad Beard entered a horse (Nightshades Maiden) for showing in class 139 in a horse show in Shelbyville, Tennessee.
- 6. On or about September 3, 2016, respondent Brad Beard entered a horse (Gin Fusion) for showing in class 187 in a horse show in Shelbyville, Tennessee.
- 7. On or about August 25, 2018, respondent Brad Beard showed a horse (Pixie's Dixie) in class 70B in a horse show in Shelbyville, Tennessee.

Conclusion of Law

Respondent Brad Beard having admitted the findings of fact set forth above, and the parties having agreed to the entry of this decision, such decision will be entered.

Order

1. Respondent Brad Beard is disqualified for three years, beginning September 6, 2020, and ending September 5, 2023, from showing, exhibiting, or entering any horse, directly or indirectly through any agent, employee, or other device, and from judging, managing or otherwise participating in any horse show, horse exhibition, or horse sale or auction, directly or indirectly through any agent, employee, or other device.

l"Participating" means engaging in any activity beyond that of a spectator in connection with a horse show, horse exhibition, or horse sale or auction, and includes, without limitation, transporting or arranging for the transportation of horses to or from equine events, personally giving instructions to exhibitors, being present in the warm-up or inspection areas, or in any area where spectators are not allowed, and financing the participation of others in equine events.

2. Respondent Brad Beard is assessed a civil penalty of \$3,850, which shall be paid by September 6, 2020, by check made payable to USDA/APHIS, indicating that the payment is in reference to HPA Docket No. 17-0096, and sent to:

The provisions of this order shall become final and effective on June 30, 2019. This order may be executed in counterparts. Copies of this decision shall be served upon the parties.
