**SUPPLEMENTAL ORDER**

Appearances:

This proceeding initiated under the Packers and Stockyards Act of 1921, as amended and supplemented (7 U.S.C. §§ 181 *et seq.*) ("Act"), with a complaint filed by the Deputy Administrator, Fair Trade Practices Program, Agricultural Marketing Service ("Complainant"), alleging that Farmington Livestock, LLC and Keith Robertson ("Respondents") willfully violated the Act and the regulations promulgated thereunder (9 C.F.R. §§ 201.1 *et seq.*).

On April 13, 2018, an order<sup>1</sup> was issued in the above-captioned matter, which, *inter alia*, suspended Respondents as registrants under the Act for a period of fourteen days, continuing until Respondent Farmington Livestock, LLC demonstrated to AMS that its Custodial Account was in balance. Such order further provided that upon expiration of the fourteen-day suspension period and upon demonstration of a Custodial Account balanced to Complainant's satisfaction, a supplemental order would be issued lifting the registration suspension.

On May 8, 2018, Complainant filed a "Motion for Issuance of Supplemental Order

Terminating Suspension” and proposed Supplemental Order.

The initial fourteen-day suspension period has expired, and Respondents have demonstrated Custodial Balance to the satisfaction of Complainant. Accordingly, the following Order is issued.

**ORDER**

1. Complainant’s “Motion for Issuance of Supplemental Order Terminating Suspension” is hereby GRANTED.
2. The suspension of Respondents’ registration is hereby TERMINATED. The April 13, 2018 Order shall remain in full force and effect in all other respects.
