

Leadership Remarks



Lisa Ramírez, EdD Director USDA Office of Partnerships and Public Engagement

Dr. Lisa R. Ramírez recently served as the Chief Innovation Officer for Lubbock ISD. She relocated to Lubbock from Washington, DC where she served as the Deputy Assistant Secretary for Policy and Programs in the Office of Elementary and Secondary Education at

the U.S. Department of Education. In this role, she oversaw a broad range of management, policy, and program functions.

Dr. Ramírez also served as the Director of the Office of Migrant Education and the Director for the Office of School Support and Rural Programs in the Office of Elementary and Secondary Education (OESE). Dr. Ramírez joined the U.S. Department of Education in 2006, when she was appointed Group Leader for the discretionary grants team, which plans and coordinates the High School Equivalency Program (HEP), College Assistance Migrant Program (CAMP), and the then active Migrant Education Even Start (MEES) program. After only one and a half years in her new role, she was promoted to Director of the Office of Migrant Education, where she led the planning and coordination of all aspects of the various programs, including grant and contract administration, policy, evaluation, and special initiatives. In 2015, she added the Office of School Support and Rural Programs to her portfolio. Even with dwindling resources including a reduction in staff, Dr. Ramírez has continued to inspire the staff in such a way that they have developed their own leadership skills and have become motivated to produce consistently higher and more effective results, both inside the office and with the field of grantees.

The daughter of migrant workers and a former migrant worker herself, Dr. Ramírez left the fields to serve in the United States Army Reserves. She financed portions of her college education through the GI Bill and began her career as an educator in 1992, first as a middle and high school teacher in English and English for Speakers of Other Languages (ESOL) in Texas, then serving as Assistant Principal and Principal. In 2004, Dr. Ramírez took on the challenge of opening the Lubbock Independent School District's first charter campus, the Ramírez Charter School. Dr. Lisa R. Ramírez brings a unique combination of personal and professional experiences to help improve the academic success of students across the country. A dynamic, change agent at heart, Dr. Ramírez has had a powerful impact on the various staffs and offices where she has worked. Correspondingly, Dr. Ramirez was recognized within the Department for her unique positive spirit, notable intelligence and outstanding leadership.

Born in Chicago, but a Texan at heart, Dr. Ramírez received her B.A., M.Ed., and Ed.D. degrees from Texas Tech University, in Lubbock, Texas. A life-long learner, she is an alumna of the Executive Leadership program at the John F. Kennedy School of Government at Harvard University and the National Hispana Leadership Institute. She is also a Pahara-Aspen Institute Fellow. Dr. Ramírez enjoys running, hiking, writing and the study of film/world cinema. Dr. Ramírez currently lives with her husband, two children and two family dogs in Alexandria, Virginia.

Mallory M. Koenings, Ph.D., RDN, (she/her/hers) National Program Leader USDA National Institute for Food and Agriculture (NIFA)

Mallory Koenings, PhD, RDN is a National Program Leader in the Division of Nutrition, Institute of Food Safety and Nutrition at the National Institute of Food and Agriculture, USDA (NIFA). Previously at NIFA, she provided national program leadership to the Expanded Food

and Nutrition Education Program (EFNEP) and the Web-based Nutrition Education, Evaluation, and Reporting System (WebNEERS) as the National EFNEP Coordinator, to advance the science of nutrition education and deliver enhanced low-income national nutrition education programs and services to consumers throughout the United States, District of Columbia, and the Territories. She also provided programmatic support for the AFRI Childhood Obesity Prevention Challenge Area Program and the AFRI Function and Efficacy of Nutrients Foundational Program. In a Special Assignment to the Office of the Director she provided support and leadership to the Science Program and Analysis Officer.

Prior to joining NIFA, Dr. Koenings specialized in designing and implementing databases for reliable public health data collection and analysis, adapting health education to meet the needs of specific populations via web-delivered interventions and mobile applications, especially young adults and preschool children. She has authored publications in journals, such as the American Journal of Lifestyle Medicine, Advances in Nutrition, and the European Journal of Clinical Nutrition. Her expertise spans healthy lifestyle behaviors, nutrition, physical activity, stress, alcohol, and sleep, paying special attention to environmental influences on nutrition and health.

Dr. Koenings has received several awards and honors, which include being named an ASN Translational Research Award Competition Finalist, the NIFA, USDA Director's Team Award, and the USDA's Abraham Lincoln Honor Award. She served as Chair of the Society for Nutrition Education and Behavior Higher Education Division 2016-2019.

Dr. Koenings received a Bachelor of Science degree in Biochemistry, a Bachelor of Science degree in Nutritional Sciences, and a certificate in Environmental Studies from the University of Maryland, College Park. She earned her doctoral degree in Nutritional Sciences with an emphasis in the built environment and health behaviors from the University of Wisconsin – Madison. She completed her dietetic internship at West Virginia University, and post-doctoral fellowships at West Virginia University and Rutgers University. Dr. Koenings also received a Certificate in Public Leadership from Brookings Executive Education.



Erica Christensen Raml (she/her) Director of Technical Assistance & Innovation Nutrition Incentive Hub – Fair Food Network

As Director of Technical Assistance & Innovation at the Nutrition Incentive Hub, Erica leads the development and delivery of training and technical assistance services for nutrition

incentive practitioners across the country. Over the past decade, Erica Christensen Raml has worked with communities across the country to increase food access and support local economies.



Erica has helped implement eight nutrition incentive programs in Washington, D.C., Little Rock, Arkansas, and New York City. She has been responsible for program outreach, data tracking, design, and implementation for programs operating at farmers' markets, health clinics, hospitals, and farm share sites. Most recently, she developed values-aligned partnerships and managed operations at a New York City-based food hub. For her work, she was named one of the top 40 under 40 by the Hunter College New York City Food Policy Center. Prior to that she coordinated training and technical assistance programs at the Wallace Center, which supported the growth of value chains and food hubs across the country.

A biracial Chinese-American, Erica holds a master's degree in global environmental politics from American University and a bachelor's degree in political science and international studies from the University of Memphis. She enjoys morning runs, spending time outdoors with her husband, and trying every bowl of ramen she can get her hands on.



Erin Smith, LMSW

Program Director, Double Up Food Bucks Mississippi Jackson Medical Mall Foundation

Erin W. Smith is the proud wife to Brett and mother of Bryce, Hampton, and Ashlynn. She is the Founder and President of Therizo Foundation, a 501(c)(3) non-profit public charity with the purpose to develop fresh fruit and vegetable incentive redemption systems supported by grocers, farmers, farmers markets and other vendors to increase access, affordability, and availability of produce to low-income and elderly households.

Since 2015, Erin has been working to fight against food insecurity matters across the state of Mississippi. She managed a statewide USDA Food Insecurity Nutrition Incentive (FINI) Grant Project 2015 to July 2019. This FINI grant project included both a nutritional incentive program and a produce prescription program. This fresh fruit and vegetable incentive and food prescription program was groundbreaking and was the first of its kind in Mississippi. Once the grant project ended, through partnership with USDA, Fair Food Network and the Jackson Medical Mall Foundation (JMMF), Erin developed and created the Double Up Food Bucks Mississippi program now being implemented through JMMF as a USDA Gus Schumacher Nutrition Incentive Program (GusNIP) Large Scale Grantee. Under Erin's leadership, most recently, the Mississippi Double Up program was awarded a \$5 million-dollar large scale nutrition incentive grant through the USDA's COVID Relief and Response (GusCRR) funding.

Erin is a proud farmer and part-owner to Particular Poultry, Inc., an eight house broiler poultry farm operation. In addition to serving the Mississippi School Boards Association and the Lincoln County United Way as a board member, she has served as a trustee for the Brookhaven Public School District since 2012. Philanthropic endeavors are essential to Erin's life philosophy of giving back. She enjoys coaching basketball to youth, and is a member of Heuck's Retreat Baptist Church, Blessings in a Backpack, the Eagle Club, and life memberships include: Junior Auxiliary of Brookhaven, Kappa Delta, Beta Sigma Chapter, University of Southern Mississippi Alumni Association, and Copiah-Lincoln Community College Alumni Association.

A graduate of the 2019 Leadership Mississippi class hosted by Mississippi Economic Council, she has also been recognized twice by the Mississippi Business Journal as a Top 50 Under 40 Business Leader in 2018 and a member of the Top 50 Leading Businesswomen Class of 2017. In 2016, she was named in the Daily Leader's



first ever Top 20 Under 40 recognition program. In 2010, she received the Outstanding Service Award by the University of Southern Mississippi. She received the Staff Member of the Year and the High-Performance Award for Copiah-Lincoln Community College in 2013 while receiving eight regional and international advisor awards from Phi Theta Kappa International Honor Society from 2008-2016. Through all of her experiences, she has established a deep understanding of what it takes to create all types of partnerships on a local, state, and national level. She most enjoys working with Mississippians to create positive outcomes for their lives!

Bill Ashton

Director, Strategic Initiatives Division Military Veterans Agricultural Liaison (MVAL) USDA Office of Partnerships and Public Engagement

William B. Ashton was born in NYC, attended schools in Brooklyn and Queens. Upon graduation from St. Francis Prep in 1976, he joined the U.S. Navy. During his 23-year career he advanced from Seaman Recruit to Lieutenant Commander and retiring in 1999.

He had a very diverse career, qualifying in "Submarines" in 1978 onboard USS L. MENDEL RIVERS (SSN 686). Reassigned as the Nuclear MM Detailer in 1980. Served on the personal staff of the Chief of Naval Operations and attaining the grade of YN1 (SS). In 1984, received orders to Naval Research Laboratory Field Site Detachment and in 1986 commissioned an Ensign under the Limited Duty Officer Program (Administration).

First tour as an officer was onboard USS MCKEE (AS 41) as Personnel and Administrative Officer. Transferred to Submarine Squadron FOUR, Charleston, SC in 1989. In 1991 reassigned as the Administrative Secretary to the Chief of Naval Personnel. In 1993, reassigned as Administrative Assistant/Aide to the Deputy for Naval Training, Washington, DC. Receiving orders in 1994, he was transferred to Submarine Squadron SIX, Norfolk, VA. In 1996, he was transferred as Officer in Charge of Personnel Support Detachment, Submarine Base, Pearl Harbor, HI. After a consolidation of all PSDs on the island, he became the OIC, PSD Hawaii. In 1997 was reassigned as OIC, PSD, Anacostia and in 1998 was reassigned for his final tour as Military Assistant to the Director, Defense Reform Initiative.

Upon retirement, he accepted a job as the Director of Operations for Winner International, manufacture and distributor of the steering wheel locking device "THE CLUB". He also became the Vice President for Operations of Winner Advertising after 16 of 17 personnel left the company. Rebuilding the company within three months, he was then asked to take over as Chief Executive Officer/Director of Winner Institute of Arts



and Science where the school attained candidacy for accreditation and Title IV funding under his leadership.

In 2002, he accepted a job as Assistant Officer in Charge of Personnel Support Activity Detachment, Washington, DC. In August 2004, he accepted a job at Commander Navy Installations Command as the PASS/Shore Corrections/TPU Program Branch Head. He took military pay timeliness from 54% to 98% during his tour. During this timeframe he became the Program Manager for Navy Family Accountability and Assessment System (NFAAS) and Navy Mobilization Processing Sites in addition to his other duties. In 2013, the PASS Program transferred Naval Personnel Command in Millington, TN and he accepted realignment as a Program Analyst for Environmental at CNIC.

During 2004, he was selected to serve on the Secretary of the Navy's Retiree Council for a period of three years. This Council reviews retiree's policies and makes recommendations to the Secretary. From April 2015 to January 2018, he served as the Security Director for the Commander, Naval Sea Systems Command Headquarters to lead the Security efforts of the command. As the Director for Security, he is responsible for four divisions to include (Operations, Inspections, Information & Industrial and the Technology Protection & International Security).

He is currently serving as the Military Veteran Agricultural Liaison for the United States Department of Agriculture. William B. Ashton was named the first permanent Military Veterans Agricultural Liaison for the United States Department of Agriculture in January 2018. In his role as liaison, Ashton will guide USDA efforts to support veterans learn and succeed through agriculture, agribusiness, in rural communities, and beyond. He was recently transferred to be the Strategic Initiatives Division Director, which includes Youth Programs, Faith Based Initiatives, Military Veterans Agricultural Liaison and Special Initiatives.

He has been appointed by the Governor of the Commonwealth of Virginia to be the Fleet Reserve Association's representative to the Joint Leadership Council. The Joint Leadership Council of Veterans Service Organizations provides a vehicle for veteran's service organizations to collaborate with the Department of Veterans Services on meeting the needs of Virginia's veterans.
