FAO workshop on Whole Genome Sequencing for Food Safety Management: The Food and Agriculture Organization of the United Nations (FAO) has issued a call for participation in a technical workshop on the use of Whole Genome Sequencing (WGS) for food safety management. The workshop will be held from April 18-20, 2023 in Rome, Italy. The workshop aims to discuss in detail the benefits and impact of WGS in food safety management and regulatory actions. Several case studies from countries where the technology is already in place will be introduced and participants will be able to consider practical and sustainable integration of WGS into their national regulatory frameworks.
