Codex Committee on Fresh Fruits and Vegetables (CCFFV)

Classification of Food and Feed: CCPR invites Members and Observers to join an EWG, chaired by the United States and co-chaired by The Netherlands, working in English, to further the revision of the Classification of Food and Feed (CXA 4-1989). The specific terms of reference are as follows:

- continue working on Classes B Primary food commodities of animal origin and E Processed food commodities of animal origin of the Classification of Food and Feed (CXA 4-1989) and prepare tables of representative commodities;
- ii) consider the proposals on the portion of the commodity to which maximum residue limits apply, and which is analyzed for Group 006 Assorted tropical and sub-tropical fruits inedible peel and Group 023 Oilseeds; and
- iii) review the *Guidelines on portion of commodities to which MRLs apply and which is analyzed* (CXG 41-1993) with a comparison to the *Classification of Food and Feed* (CXA 4-1989) to consider revocation of CXG41 to avoid coexistence of the two documents addressing the same provisions. The EWG should consider any provisions from CXG41 that could still be integrated into the revised Classification and make a proposal for consideration by CCPR54.

Enhancement of work management of CCPR and JMPR: CCPR invites Members and Observers to join an EWG, chaired by the United States and co-chaired by Costa Rica, France, Germany and Uganda, working in English and Spanish, to explore the enhancement of work management by the CCPR and the FAO/World Health Organization (WHO) Joint Meeting on Pesticide Residues (JMPR). The specific terms of reference are as follows:

- i) prepare a Circular Letter (CL) to request information from members and observers on the need to enhance CCPR/JMPR and the associated opportunities and challenges. The CL may invite members and observers to consider a second or possibly subsequent workshops that would expand on and further develop some of the themes addressed in the virtual workshop sponsored by CropLife International on March 31, 2022, as described in CX/PR 22/53/20.
- ii) prepare, on the basis of the responses to the CL a summary of the submitted information and a discussion paper that summarizes findings for consideration at CCPR54 and later transmission to JMPR as appropriate.
- iii) coordinate work with related EWGs such as the EWGs on priority lists, national registration database, unsupported compounds.
