Overview

Office of Management and Budget (OMB) requires the U.S. Department of Agriculture (USDA or the Department) to maintain a plan for agency operations in the absence of appropriations. This plan has been developed to meet OMB requirements and has been sectioned out by the Department's Agencies and Staff Offices. This plan may be modified whenever there is a change in the source of funding for an agency program or any significant modification, expansion, or reduction in agency program activities; upon receipt of additional guidance from OMB, the Office of Personnel Management (OPM), or the Department of Justice; or as circumstances otherwise warrant. At a minimum, the plan will be reviewed and updated every two years.

The Anti-Deficiency Act (ADA) prohibits agencies from incurring obligations in advance of, or that exceed, an appropriation. Thus, with certain limited exceptions, an agency cannot incur obligations when the funding source for the obligation is an appropriation that has lapsed. Any activities that would incur a new obligation must be suspended and are prohibited. Activities that are underway that would lead to a increased obligations or incurred costs must cease. Violations of the Antideficiency Act can result in administrative and criminal penalties.

In the event of a lapse in appropriations, the Department will immediately suspend regular agency operations. Certain functions and activities, however, may be continued even in the absence of an annual appropriations Act or continuing resolution. The principal guidance utilized by the Department on the types of functions and activities that may be continued during a lapse in appropriations is in the Attorney General's opinion on the continuance of Governmental functions during a temporary lapse in appropriations dated January 16, 1981, updated by an Office of Legal Counsel's memorandum dated August 16, 1995.

Accordingly, Department functions and activities that may be continued in the event of a lapse in appropriations are those that are:

1. Financed by a resource other than current year annual appropriations;
2. Expressly authorized by law to continue in the absence of appropriations;
3. Authorized by necessary implication to continue in the absence of appropriations;
4. Necessary to discharge the President's constitutional duties and powers; and
5. Related to emergencies where there is a reasonable likelihood that the safety of human life or the protection of property would be compromised, in some significant degree, by delay in performance.

Orderly Shutdown Procedures

Approximately two business days before a potential lapse in appropriations, the Department will notify employees of the status of funding and inform employees of their work and pay status under a lapse in appropriations. After OMB has communicated to the Department that appropriations have lapsed, the Department will commence an orderly shutdown of regular agency operations.

All employees are to report to duty on their next scheduled workday. At this time, employees will again be instructed of their status – i.e., whether they are to be furloughed or excepted from furlough for a short period to perform extended orderly shutdown activities or on an intermittent or ongoing basis to perform otherwise excepted functions – and will be given instructions on performing shutdown procedures. Resumption of Regular Operations

Furloughed employees are expected to monitor the status of the Department's operations to determine when they are to return to duty by visiting OPM's operating status website:

Upon the enactment of appropriations and the resumption of regular operations, Departmental Staff Offices and Agencies may resume program activities consistent with all applicable Departmental operating procedures. Furloughed employees will be expected to return to duty. This will normally be the employee's next scheduled workday upon the resumption of regular operations. Supervisors may exercise flexibilities if employees have problems returning to work on the day specified, such as authorizing the use of accrued annual leave, compensatory time off, or credit hours.

Select FSA leadership at headquarters and state offices will be excepted on call to ensure continuity of operations in the case of a natural disaster response and to ensure the security interest of CCC. If a shutdown continues past 10 days, additionally, one farm loan employee and/or one county office farm program employee per service center will be excepted on call to complete certain loan processing items to protect the security interest of the government and to prevent the loss of security or loss of value to security for the borrower. This will not include any new loan processing but will include continuing liens, processing protective advances, if needed to preserve security (including inventory properties) and reviewing a borrower's account to gather the necessary information to respond to a bankruptcy notification to identify FSA debts and assets. Because the excepted work is ongoing and intermittent throughout the day, the employee shall remain at work to be immediately available to perform the excepted function. If there are intervals of time where the employee is not performing and is not	

expected to perform excepted work, the employee may perform limited non-excepted work. That work must not interfere with the proper execution of or readiness to perform an excepted activity.

Significant FSA activities that will cease during a lapse include:

- Implementation and payment processing of remaining Supplemental Disaster Assistance programs authorized in the American Relief Act (SDRP Stage 1, SDRP Stage 2, ELRP 2023 and 2024 for Flood and Wildfire, Block Grants and any outstanding ECAP payment modifications)
- Implementation and processing of disaster assistance payments in support of significant weather-related disasters
- Accepting and processing farm and commodity loan making activities which provides critical financing during (or right after) harvest
- Development and implementation of legislation authorized in H.R. 1 which includes significant changes to ARC/PLC base acres, marketing assistance loan repayment calculations, disaster assistance program policy updates, and dairy margin coverage program several other changes.
- Technical assistance and cost-share assistance related to critical farmland and forestland rehabilitation necessary to support continued agricultural and forestry related activities following widespread disaster events (hurricanes, wildfires, tornadoes, flood, etc.)

Certain NWCC functions are considered excepted because they are required for the safety of human life or the protection of Federal property. This includes streamflow and flood forecasting, verification of weather models, water supply planning, snowpack, air temperatures, and precipitation monitoring for avalanche mitigation and fire prevention, suppression, and pre-suppression work.

National Soil Survey Center (NSSC)

Certain NSSC activities are considered excepted because they are required to protect Federal property. This includes checking the Kellogg Soil Survey Laboratory (KSSL) facility which houses sensitive lab equipment connected to gases, performing periodic facility safety reviews and maintaining Web Soil Survey (WSS).

Key operational activities such as processing of contract payments to farmers and ranchers, conservation planning activities, ongoing collaborative projects with key soil and conservation partners, and processing of payments for outstanding contracts and agreements.

<p>Core programs of the nutrition safety net, including the Supplemental Nutrition Assistance Program (SNAP), the Child Nutrition (CN) programs and the Special Supplemental Nutrition Program for Women, Infants and Children (WIC) shall continue operations during a lapse in appropriations, subject to the availability of funding. These include: for the National Nutrition Monitoring and Related Research Act of 1990 and Agricultural Act of 2014, FNS will designate excepted staff working on the development of the Dietary Guidelines for Americans; and for H.R. 1, FNS will designate excepted staff to work on provisions that affect changes to SNAP eligibility, benefits, and program administration.</p> <p>Supplemental Nutrition Assistance Program (SNAP): OMB's General Counsel provided a letter to USDA on May 23, 2025 stating that there is a bona fide need to obligate benefits for October – the first month of the fiscal year – during or prior to the month of September, thereby guaranteeing that benefit funds are available for program operations even in the event of a government shutdown at the beginning of a fiscal year. In addition, Congressional intent is evident that SNAP's operations should continue since the program has been provided with multi-year contingency funds that can be used for State Administrative Expenses to ensure that the State can also continue operations during a Federal Government shutdown. These multi-year contingency funds are also available to fund participant benefits in the event that a lapse occurs in the middle of the fiscal year. To fulfill this Congressional intent, it is necessary that a limited number of FNS employees be excepted from furlough to support program operations. This plan reflects the continuation of the essential Federal activities and funding to maintain the core programs of the nutrition safety net. Additionally, other mandatory activities under the Food and Nutrition Act of 2008, including but not limited to Food Distribution on Indian Reservations and nutrition assistance block grants, will continue as will FNS' disaster response activities under the Food and Nutrition Act of 2008 and the Stafford Act, to the extent permitted by multi-year and directly appropriated funds.

FNS staff funded by Child Nutrition direct appropriations will be regarded as exempt and continue in duty status during a lapse in appropriations. As a part of the preparations for any potential lapse, the Office of Financial Management will identify all staff currently in exempt status and provide that information to the Administrator, the Director of Human Resources, and the Senior Leadership team. Exempt staff will be notified of their status and its implications prior to any lapse in appropriations.

All Federal activities supporting unfunded discretionary programs would cease, although State activity may continue out of inventory and previously awarded grant funds. All technical assistance and management evaluations with State or other partners will cease. New store authorization for SNAP and WIC programs will cease. In addition, the following activities will also cease: financial management beyond funds management; non-priority regulatory work; travel and conference presentation/participation.

During any lapse in appropriation FNS works to keep excepted staff to the minimum necessary to support program continuation. FNS will use the USDA recommended recall process to bring furloughed staff back to duty to accomplish critical tasks for programs funded through the SNAP, CNP and WIC accounts on an as needed basis. OIG would significantly reduce its law enforcement-related activities, while suspending all audit and analytics and innovation-related activities, as well as all mission support activities except for those supporting ongoing law enforcement and Hotline activities, as set forth above.

Based on its mission, OIG has identified only activities needed to manage and continue orderly shutdown, continue residual operations, and ensure safety and security against loss of life as those activities that would continue during any Government shutdown. OIG's shutdown plan includes an appropriate number of personnel in the Office of Investigations who are required to work in an ad hoc capacity because of their involvement in specific law enforcement activities that occur during the period of the shutdown. For planning purposes, OIG anticipates 8; however, 24 additional agents may return to duty if they are engaged in judicial proceedings as directed by a court, which include activities such as serving arrest and search warrants or testifying in court proceedings such as before a grand jury or in a trial. These employees would work only for the duration of the specific activity in which they are involved. Certain employees, whose functions may prove to be excepted, will be placed in an "on call as needed" status while furloughed. "On call as needed" shall mean they may be contacted to return to duty to support the excepted functions and activities of OIG as needed.
